

# Busy Mom Consignor Agreement

By consigning with Happy Happy Hippos Seasonal Children Consignment Sale by Cindy McWilliams and Stephanie Thomas, ("HappyHappyHippos"), I agree that Happy Happy Hippos is not responsible for any lost, or damage to merchandise on consignment due to fire, theft, accident or any other cause. I understand that I have complete title to the merchandise consigned and I will not hold Happy Happy Hippos responsible for any claim of title to it.

As a busy mom consignor, I understand that I will collect 45% of the sale price of my items sold on consignment, the tagger will collect 25% and Happy Happy Hippos will receive 30%. I also understand that as a busy mom consignor I **can not** volunteer. I can still attend the consignor presale on Thursday evening. I also agree to pay a \$12 Consignor Participation fee which is due upon registration as a consignor. A material fee will be paid to the tagger when dropping off items to help cover the cost of hangers, cardstock, printer ink, safety pins, tape and other items needed to prepare items for the Happy Happy Hippos Sale. The material fee is \$20 for the first 250 items and \$5 for each additional 50 items. The material fee must be paid in cash to the tagger.

All items must be clean and in working condition when brought to the tagger. Clothing must be washed and neatly folded in boxes or bins. No clothing can be brought in garbage bags. Outfits must be folded together so the tagger can easily identify that they belong together. Clothing must be season appropriate for the event. At the Spring event, no jackets, coats, heavy winter clothing, or holiday themed outfits. At the Fall event, all types of clothing will be accepted. Toys that have small parts must have small parts in a ziploc type bag. Any item that requires batteries must have working batteries in the item. If an item does not have working batteries, I will be charged a dollar per battery that must be bought for the item and will be deducted from my check. Any item that the tagger finds that does not meet Happy Happy Hippos standards of quality will not be accepted and will be donated. If I, the busy mom consignor, have more than 10% of my items that are not accepted, I will not be allowed to use the busy mom tagging service at the next event.

I, the busy mom consignor, understand that my items will be priced by the tagger. The tagger will use their experience and judgment in pricing items. Items will be price moderately and to sell. The tagger may group like items together in order to increase the likely hood of selling the item. All items will be marked to sell at discount on Sat. night after the sale closes during the Facebook presale event and all day on Sunday. I must inform Happy Happy Hippos if I will be picking up unsold items. If picking up unsold items, I will be given an appointment time for the Monday after the sale between 11am and 8pm. Unsold items will be picked up at the Hernando County Fairgrounds. Any item left after 8pm will become the property of Happy Happy Hippos, and may be donated to a Charity chosen by Happy Happy Hippos and I will not be paid for them.

Happy Happy Hippos will mail me a check within 14 business days or less from the end of the event. I will cash the check within 30 days of receiving it.

I have checked my items against the recall list and none of my items are on the list. I understand that if one of my items is on the recall list, Happy Happy Hippos will pull it from the sales floor at any time during the sale and it will not be sold and will be returned to me.

If I am selling a carseat, the carseat must be less than 6 years old and have a manufactured sticker on it. I also must provide the tagger with a signed carseat waiver.
